## MEETING HIGHLIGHTS

of

April 2024

1. First meeting of the newly formed Lambton Group OPP Detachment Board under the CSPA – welcome to all members.
2. Acting Staff Sgt. Rick Mathieson summarized activities including the January and February policing report:

### Command:

Planning for major deployment in Grand Bend. 12 members will be deployed each weekend starting May 24 weekend.

### CSCU

• As a result of several overdose deaths on Walpole Island, Lambton CSCU conducted directed patrols on Walpole First Nation which resulted in 3 persons arrested, 4 charges (Drug Trafficking, Resist Arrest). Drugs seized: 132 grams of Fentanyl, 11 grams of raw Fentanyl, \$969 cash, and drug trafficking paraphernalia. Walpole Island Police also conducted directed patrols that evening and Lambton CSCU assisted which resulted in 2 persons arrested; 9 charges (Drug Trafficking, Firearm related). Drugs seized: 26 grams of Fentanyl and 41 grams of Cocaine.

• Lambton CSCU wrote two S.11 search warrants in relation to a drug trafficker in St. Clair Twp. Two separate warrant locations. In total 4 person arrested, 8 charges (Drug Trafficking & Breach). Drugs seized: 73 grams of Cocaine, 20 grams of Fentanyl and drug trafficking paraphernalia.

- Lambton CSCU wrote a S. 487 warrant on a storage facility in Petrolia, officers seized an e-bike valued at \$2000, with one person charged with Possession of Property Obtained by Crime.

## Lambton Crime

Crime members and the OPP Criminal Investigations Branch still investigating Andrew CHUTE homicide at the Marthaville Conservation homicide.

- Crime members and CIB are actively investigating an unsolved homicide of David Oliver on the Kettle & Stoney Point First Nation.
- Crime members investigating missing person Deanna Timms.
- 4 Criminal Harassment investigations.
- 2 suspicious fires investigated. Investigations continue.
- 8 sexual assaults and one indecent act cases investigated.
- Two fraud investigations.
- 23 Sudden Deaths investigated.
- Appeal process began for R Vs Trowbridge verdict ongoing.
- Arkona Bank robbery investigation continues, leads are uncovering in multi-jurisdictional robbery organization.
- One search warrant executed for possession of child pornography. Two arrested and charged

3. Inspector Avery highlighted a recent successful operation where Lambton OPP were able to assist the Sarnia Police Services in relation to a robbery. As part of the ongoing Sarnia Police investigation, suspect and vehicle information was shared with neighbouring police services. During the evening of April 25<sup>th</sup>, 2024, Lambton County OPP located the vehicle at a Confederation Line residence, aiding Sarnia Police Services to ultimately place arrests and seize 309 grams of cocaine | 56 grams of fentanyl | \$3400 in cash | A .38 calibre handgun. Sarnia Police Services will be releasing a full media statement soon. This is an excellent example of how policing works together.
